

NOTICE OF PUBLIC HEARING


Notice is hereby given that a Public Hearing will be held by the Council of the City of Parksville on **Monday, March 4, 2019,** at **6 pm** in the Parksville Civic and Technology Centre, 100 Jensen Avenue East, Parksville, BC to consider public representations on the following bylaws:

"ZONING AND DEVELOPMENT AMENDMENT BYLAW, 2018, NO. 2000.122"

proposes to amend "City of Parksville Zoning and Development Bylaw, 1994, No. 2000".

In general terms, the purpose of the proposed amendment is to add a Downtown Residential Commercial DRC-1 zone and to alter the zoning map from the Single Family Residential RS-1 zone to the new Downtown Residential Commercial DRC-1 zone in order to allow apartments, multiple family residential development, retail, offices, parking or a combination thereof at the following properties shown shaded on the map below:
