# Highlights from Council Meeting on April 23, 2025

Mayor O'Brien recognized the Coast Salish peoples and their traditional territory upon which we gather with gratitude.

## COUNCIL RECEIVED THE FOLLOWING DELEGATIONS

- J. Stavroff updated the City on the community initiative to memorialize Phil St. Luke. Council endorsed a motion to name a trail, pathway or park in memory of Phil St. Luke.
- The applicant gave a presentation regarding the application to facilitate an Extreme Eatery patio on public property on Morison Avenue.

## COUNCIL RECEIVED THE FOLLOWING REPORTS

- Confirmed direction provided at the April 9 Committee of the Whole meeting and directed staff to prepare the changes proposed for the 2025 2029 amended financial plan.
- Approved issuance of a development permit to facilitate renovation of an existing residential building at 1480 Seaway Drive.
- Received a report regarding an application to facilitate a street patio adjacent Extreme Eatery on Morison Avenue. A zoning amendment bylaw was advanced, staff were directed to prepare a licence of occupation with the application and to refer the application to the Parksville Downtown Business Association, Parksville and District Chamber of Commerce and Parksville Qualicum Beach Tourism Association.
