# Highlights from the Council Meeting on December 15, 2025

Mayor O'Brien recognized the Coast Salish peoples and their traditional territory upon which we gather with gratitude.

#### **REPORTS**

- Authorized issuance of a development variance permit to facilitate a carriage house at 360 Hirst Avenue West.
- Received a report regarding consideration of anticipated twenty-year housing need and associated housing policies and accepted the staff review of the associated bylaws.
- Received a report regarding the 2026 2030 Financial Plan. The associated bylaw was advanced to the statutory process.
- Received a report on a new inter-community business licence bylaw and agreement. The bylaw was advanced to the statutory process and staff authorized to execute the agreement upon adoption of the bylaw.
- Approved the 2026 fee-for-service agreement with the Parksville and District Chamber of Commerce for operation of the Visitor Centre.
- Approved a five-year operating agreement with the Parksville Beach Festival Society for operation of the Parksville Outdoor Theatre located in the Community Park.
- Approved a three-year lease agreement with the Parksville Curling Club Society for the District 69 Ice Arena located in the Community Park.

  - o "Inter-Community Business Licence Bylaw, 2025, No. 1600" (new ICBL program)

  - o "Zoning and Development Amendment Bylaw, 2025, No. 2000.157" (Map and text amendment to Comprehensive Development CD-38 at 386 Hirst Avenue West)
- The following bylaw was adopted:
  - o "Five Year Financial Plan Amendment Bylaw, 2025 2029, No. 1594.2" (amended 2025 2029 financial plan)

## **COMMITTEE OF THE WHOLE**

• Council received a staff presentation and provided direction to staff on the scope of the Official Community Plan review scheduled for 2026.

### **NOTICE OF MOTION**

- Approved City participation in the provincial electric kick scooter pilot project.
- Approved a motion directing staff to provide a report outlining required work tasks and related budget costs
  necessary to implement a name change for Highway 4 Alberni Highway to Mountainview Boulevard from 19A
  (Ocean Boulevard) to the train station; to implement a name change for Highway 19A Island Highway to Ocean
  Boulevard, for the full length of the road within City limits; and to reduce the speed limits on specific roads
  within Parksville.
- Councillor Wood provided notice of a motion for submission of a resolution to the 2026 Association of Vancouver Island and Coastal Communities convention regarding provincial participation in growth-related infrastructure to accelerate housing delivery.
- Councillor Wood provided notice of a motion to request a brief staff report summarizing the most recent Emergency Management Oceanside emergency weather activation and response.
- Approved a motion to advance "Zoning and Development Amendment Bylaw, 2025, No. 2000.155" to a public hearing to be held on Monday, January 19, 2026, starting at 1 pm in the Forum at the Parksville Civic and Technology Centre.
