City Services

Highway 19A Improvements

Construction on municipal infrastructure upgrades on Highway 19A between Moilliet Street and Rushton Lane has begun. Improvements include reconstruction, widening and upgrading of about 800 meters of roadway and underground infrastructure along 19A from Moilliet, west through the Bay Avenue intersection. Highlights include the realignment and reconstruction of Bay with sidewalks, bike lanes and streetlights, new intersection and traffic signals at Bay and 19A, upgraded traffic signals at Moilliet and 19A, new water and storm drainage infrastructure on 19A and Bay, and a new continuous sidewalk connection from Dogwood Street to Rushton Lane on Highway 19A.

Construction is planned to be substantially complete by October 2013. As with all major road construction work, there may be inconveniences during construction. Two lanes of traffic on Highway 19A will be maintained for

vehicle traffic. In order to perform work in a safe and efficient manner, temporary lane and road closures and potable water disruptions may occur. Residents will be notified by the contractor at least 48 hours prior to any disruption.

Electrical Vehicle Charging Stations New to Parksville

With funding through the Community Charging Infrastructure Fund, the City has installed two electric vehicle charging stations at the Parksville Civic and Technology Centre and one in the Community Park. Through this fund, stations are popping up around the province, allowing residents and visitors to charge their electric vehicles.

Initially the charging service will be at no cost to the car owner/driver and charging will be accessible 24 hours a day. The City will revisit this after the first year of operation. To use the station, a card may be purchased from AddENERGIE for \$10. www.vernetwork.net
