PUBLIC INFORMATION SESSIONS

Wednesday, May 20, 7 pm, Nanoose Place (Regional District of Nanaimo)

The public info sessions are a drop-in format to provide residents an opportunity to review preliminary designs for the water treatment and intake facilities, funding options and costs. Consultants and staff will answer any questions you might have and respond to concerns about the project.

PUBLIC TOWN HALL MEETING

Council wishes to receive comments from Parksville residents at a town hall meeting on May 28. This Council-hosted meeting is an opportunity for community members to voice their opinions about the water project. It is important for members of Parksville Council to hear the views of Parksville residents.

The ERWS project includes a new river water supply intake, a new water treatment plant, water distribution system upgrade and an aquifer storage and recovery system. ERWS is a joint venture agreement between the City of Parksville and the Regional District of Nanaimo formed to secure a bulk water supply from the Englishman River. Water Conservation Level 2

Now in effect, permits watering every other day between the hours of 6 am to 10 am and 6 pm to 10 pm for no more than a maximum of two hours watering per day. We wish to thank residents for their efforts to conserve water this summer. Watering of vegetable gardens, shrubs, trees and flowers is restricted to a hand-held container or a hose with shut-off nozzle if watered outside of permitted times. Budget and Property Taxes

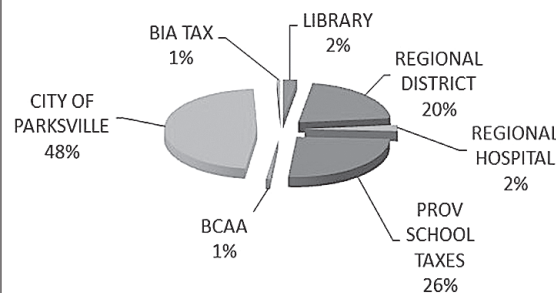
The 2015 budget was adopted in April and a new tax rate was established; Council set the residential and business property tax increase at 1.5% for 2015. The tax increase for subsequent years is projected to be 2% for 2016 and 2.5% for each of the years 2017-2019. This year's increase of 1.5%, the lowest in many years, is the result of continued prudent and responsible fiscal management.

The general fund budget of \$27,339,740 includes capital expenditures of \$11,083,370. Major capital projects in 2015 include the second phase Temple Street upgrades, Community Park and Kin Hut washrooms, Corfield Street - Stanford to 19A road project, and Ermineskin Road and Banks Avenue water main and road repairs.

When other government tax collections are added in, the total tax increase for the average priced residential property is about 2.0%. For a home with the average assessed property value of \$296,500, the City portion of total property taxes will increase by \$15.70. The library, Nanaimo Regional District, regional wastewater and regional hospital charges will increase by \$32.27. The school tax change is not released by the province at this time. The estimated property taxes for the average house (using an estimate for the school tax) are \$2,660.

Council also approved the 2015-2019 final financial plan now on the City's website [\[Quicklinks/Reports\]](#). This plan sets out the financial requirements to enable departments to carry out projects for 2015.
