The Community Park Ventureland Playground was vandalized again this past November. This time, a slide was burned through with a flare or firecracker and unfortunately the damage was so extensive, the slide is no longer usable. Another slide was damaged in a similar fashion two years ago and although we were able to make temporary repairs, this slide has also been removed. The cost to replace both slides is more than \$10,000. 
2017 Special Events Applications


