
Community Park Resident Survey

Budget and Property Taxes

The City's 2017 budget, adopted on May 1, delivered a balanced budget for the 2017 financial year and established the 2017 tax rate increase. Council approved the 2017-2021 final financial plan and set the overall property tax increase for 2017 at 4% for all classes except Class 5 Light Industry which was set at 11.5%. This increase is higher in order to bring the light industry rate more in line with the business class rate. The tax increase is budgeted to be 4% for subsequent years, 2018 to 2021. The budget and final financial plan available on the City's website [Quicklinks/Reports], sets the financial authority to enable departments to carryout 2017 projects.

When other government tax collections are added in, the total tax increase for the average priced residential property is about 1.52%. For a home with the average assessed property value (\$340,900 in 2017), the City portion of total property taxes will increase by approximately \$51.70 from 2016. The Regional District of Nanaimo, regional wastewater, regional hospital and library taxes will increase by about \$13 and the local school tax decreased by about \$26.

Tax notices will be mailed later this month and to avoid penalty, payment must be received by the City and the homeowner grant claimed by Tuesday July 4, 2017.

Water Restriction Stage 2

Stage 2 is now in effect in the City of Parksville for the months of May through September unless otherwise advised by the City. With Stage 2, sprinkling can only occur on even days for even-numbered houses and on odd days for odd-numbered houses. Sprinkling is permitted for a maximum of two hours between 7-10 am or 7-10 pm. Although it has been a rainy spi

or 7-10 pm. Although it has been a rainy spring so far, dry summer conditions will be here soon. Taking conservation measures early, before water supplies come under stress, is essential to ensure we maintain an adequate water supply through the hot dry summers we have come to expect. Raising \$\$ for a New Splash Park

The Parksville Lions Club and the Rotary Club of Parksville AM are making a splash to raise \$100,000 towards replacement of the outdated spray park in the Community Park built in 1992 by the Parksville Lions. New splash parks constructed or significantly renovated require a construction permit and structures, decks and surfaces must meet Island Health standards. Open until September 5, the splash park will be rebuilt over the winter and ready by May 2018.



The City's contribution will be \$200,000 and we are grateful the Rotary and Lions have committed to raise \$100,000 from the community. Additional funds will assist with ongoing maintenance of the splash park. The cost of \$300,000 includes dismantling of existing spray park, waterlines, drain infrastructure, new equipment to meet current regulations, new surface, installation, signage and landscaping.

Things to Know

PDBA Wayfinding Project

The Parksville Downtown Business Association will host a public information session on Tuesday, May 30 at the Parksville Community and Conference Centre. Residents are encouraged to drop in between 2 and 7 pm to learn about the City of Parksville-PDBA joint wayfinding system, designed to create a more pedestrian-friendly downtown while boosting economic activity and improving safety.

Permissive Tax Exemptions

Under the provisions of the Community Charter, Council may exempt land and/or improvements from municipal property taxes for the next calendar year, subject to certain requirements which in general, restrict exemption to non-profit organizations using the lands for specific non-profit purposes. Application deadline is noon, June 30. Details, form and policy may be obtained from City Hall or from the website [Public Notices].

Community ReGreening Program Funding

Many of the City's urban forests have been in decline over the past few years and we have seen significant necessary tree removals. This fall, the funds will be used to continue the replanting program.
