Public Hearing – 222 Corfield

The public hearing for 222 Corfield Street South is being held tonight (Tuesday, June 19), at 6 pm at the Parksville Community and Conference Centre (Seaside Auditorium), 132 Jensen Avenue East, to consider public representations on the "Zoning And Development Amendment Bylaw, 2018, No. 2000.116".

The purpose of the proposed amendment is to alter the zoning for 222 Corfield Street South from the High Density Residential RS-3 zone to the Comprehensive Development CD-27 zone to facilitate a supportive housing facility, shelter facility, food preparation facility, apartment and multiple family residential use.

Parksville Votes 2018

You may vote in the Parksville municipal election as a resident elector if you meet all of these requirements; it does not matter if you rent or own your own home.

You are a Canadian citizen; AND

- You are or will be 18 years of age or more (October 20, 2000) on or before general voting day; AND
- You have lived in BC for at least 6 months (as of April 19, 2018) prior to registration; AND
- You have lived in or have owned property in Parksville for at least 30 days (as of September 19, 2018) prior to registration; AND
- You are not disqualified from voting by the Local Government Act or any other act.

Stage 2 Watering Restrictions

Our thanks to City residents for their cooperation and support during the temporary comprehensive watering ban necessary last week when the new transmission main was connected to the Springwood reservoir.

Stage 2 watering restrictions now back in effect, allow for sprinkling every other day based on odd and even house numbers between the hours of 7-10 am or 7-10 pm for a maximum of two hours per day. Hand watering, drip irrigation and watering of vegetable gardens are permitted any time. Residents are encouraged to adjust sprinkler systems to run between 7-10 am or 7-10 pm. These times also apply to multi-unit strata developments unless issued a special permit by the City.

When arriving to vote, you will be required to provide two pieces of identification; one containing your name and address, the other containing your name and signature. If you do not have documentation showing residency, then two pieces of identification (with at least one with a signature) are still required and you will be required to make a "solemn declaration" as to your residency.

Up-to-date election information is available on the City's website, accessible from a Quicklink on the home page and on this page each month until the election on October 20.

Candidate information sessions will be offered on Wednesday, July 11 from 2 to 3 pm and from 5 to 6 pm in the Forum, Parksville Civic and Technology Centre (100 Jensen Avenue East). Sessions are geared to potential candidates and campaign workers; however anyone interested is welcome to join the group. Potential candidates need only attend one session.

Things to Know

- Property Taxes Due July 3 Tax notices for the current year were mailed in May. Contact the City (250 248-6144) if you have not received your notice. Prior to July 3, residents must claim the homeowner grant by bringing the completed application to City Hall or by claiming the grant online [Online Services]. Homeowner grant applications must be completed each year that you are eligible. If the July 3 deadline is not met, your property tax account will have an outstanding balance and receive an immediate 5% penalty.
- Permissive Tax Exemptions under the provisions of the Community Charter, Council may exempt land and/or improvements from municipal property taxes for the next calendar year, subject to certain requirements which in general, restrict exemption to non-profit organizations using the lands for specific non-profit purposes. Application deadline is noon, June 29. Details, form and policy may be obtained from City Hall or from the website [City Hall/ Mayor and Council/Permissive Tax Exemptions].
