#### Parksville Aquatic and Recreation Centre Project Announced

At the February 1 meeting, Council released the "Parksville Pool and Multiplex Facility Feasibility Study" along with background, reports, timelines, and stakeholder engagement results. All documents are available on our public engagement platform, Let's Talk Parksville. The first step in a complex multi-year process, the report summarizes the feasibility and benefits of a multi-use aquatic centre in Parksville and shows Despard Avenue as the test site for conceptual design and further consideration.



As soon as it is safe to do so, we will begin in-person community engagement. In the meantime, we will look to other engagement opportunities and encourage residents to share comments, ideas, ask questions and signup for project updates through *Let's Talk Parksville*. Comments may also be emailed to <u>letstalk@parksville.ca</u>.



During phase 2, the community will be asked to help finetune the concept presented in the feasibility study. Based on this input and the results of studies and assessments, we expect to see substantial changes to the concepts. A project consultant will facilitate community involvement and provide final detailed design and cost estimates for construction of the project and its operations. When

design, cost estimates and potential grants are determined and prior to construction, electors will be asked for approval to borrow through a referendum.

# Parksville 2021 Budget Open Meetings

At this time, City of Parksville open budget deliberation meetings to discuss the 2021 municipal budget and 2021-2025 financial plan are scheduled for March 8,

March 29 and April 12 (if required). Due to the evolving COVID-19 situation and until further notice, Council meetings are closed to in-person attendance by the public.



Receiving public input into the budget is an important part of the financial planning process. Please note, all comments received about the City's budget will form part of the public record. Here are the ways residents may engage in the budget process:

- Comments may be submitted by email to <u>council@parksville.ca</u>. To be considered by Council during the meetings, written comments should be received by noon on the Friday, the week prior to the meeting (March 5, March 26 and April 9). Residents may watch Council budget deliberation meetings online, viewed through <u>webstreaming</u> from the City's website.
- Real-time comments can be submitted by email to <u>council@parksville.ca</u> while the meetings are underway and the comments will be addressed by Council during the meeting.
- Comments may also be posted to the City's online engagement site, Let's Talk Parksville.
- The meeting videos are archived from the City's website for viewing at another time.

Parksville Qualicum Foundation and New Healthy Communities Initiative

#### **Beach Closures to Dogs**

To limit disturbance of migrating Black Brant geese, our beaches are subject to seasonal "no dog" restrictions. This applies to both on-leash and off-leash within the Parksville-Qualicum Beach Wildlife Manager Area. Rathtrevor Beach is closed February 15 to April 15 and Parksville Bay Beach from March 1 to April 30.

### **City Services**

#### **Watermain Flushing**

The City's annual watermain flushing program runs through early April. An important part of our ongoing maintenance program, flushing ensures the integrity of the water supply system. Flushing occurs mainly between 7 am and 3:30 pm, weekdays. Residents can expect some discolouration of water and intermittent drops in pressure; keep a fresh supply of drinking water in your fridge. Check for discolouration of water before doing laundry and if discoloured, run outside tap (after 3:30 pm) until clear. Pleas

#### **Residential Family Water Rates**

Large families with five or more immediate family members consisting of parents and dependent children less than eighteen years of age may qualify for modified water rates.

Application deadline is February

#### **Spring Grant-in-Aid Applications**

Subject to the provisions of the City's grant-inaid applications policy, the City may provide financial assistance to community groups and organizations for events that benefit our citizens and visitors. Community non-profit organizations in the arts, cultural, recreational, or social services fields are eligible. Deadline 3 pm, March 1.
