



Dedicated Memorial Program

The City's dedicated memorial program was developed to allow citizens, community groups, businesses or organizations to purchase a bench or tree to enhance our parks in honour of a loved one.



Bench Fee - \$3,000

Fee includes the cost of a park bench, a bronze plaque ($10 \times 18 \text{ cm}$), installation, maintenance and repair of the bench for ten years.

Tree Fee - \$1,000

Fee includes a specimen tree chosen by City arborist, a suitable species for the location, bronze plaque ($10 \times 18 \text{ cm}$) on a paving stone, planting, plaque installation at the base of the tree and maintenance for ten years.

What happens after I submit my application?

- An onsite meeting will be scheduled between the applicant and staff to determine a suitable location within a specific park or trail system.
- Payment will be required immediately after location has been confirmed.
- Plaque will be ordered once inscription has been approved by the applicant. In the case of vandalism or a stolen plaque, the City will provide a one-time free plaque replacement.
- Minimum of 8 to 10 weeks is required for installation of bench; subject to staff availability with installation times subject to change.
- Tree planting will occur in the late fall or early spring, at the discretion of the City arborist.

Memorial Bench Terms and Conditions		
 The term of this agreement is for ten years starting on the date of purchase. After ten years the bench and space will be offered to the public for a new memorial dedication. No additional items are to be included in the memorial such as charms or objects placed on the bench or the surrounding concrete base; these will be removed by City staff. 		
Memorial Tree Terms and Conditions		
 The City of Parksville will choose a specimen tree suitable for the site which will be planted in late fall, or early spring at the discretion of the City arborist. A tree purchase is for the life of the tree, with a ten-year guarantee; if the tree dies within 10 years, the City will replace it. After ten years, the City may remove the tree and plaque at its discretion. The City will use reasonable efforts to notify the donor of significant changes. No additional items are to be included in the memorial such as charms or objects within the tree ring or on the tree; these will be removed by City staff.
