# COVID-19 Update

Pandemic restrictions which prohibit gatherings and events as well as meeting with people outside of your immediate household, have been extended until midnight, January 8. These restrictions will help to keep our businesses and schools open and our hospitals and communities safe. Thank you for continuing to do your part to reduce the spread of COVID-19.



## Province-wide restrictions:

- Masks are required in British Columbia in all public indoor settings and workplaces.
- Spend time with those in your household or core bubble only.
- Explore close to home and avoid non-essential travel.
- Enjoy a walk or hike with a friend, but do not gather outdoors.

Questions about COVID-19 such as symptoms or exposure should be addressed directly to Island Health (not your local government). ## Council Meeting Participation Affected by COVID-19 Restrictions

The December 2 Public Health Order related to gatherings and events, prevents in-person attendance by the public at Council meetings, hearings, committee meetings, open houses, and other in-person meetings. Due to these restrictions, as with other municipalities, the City is not currently able to offer in-person public participation at Council meetings and public hearings.

Should restrictions remain in place for the next Council meeting on January 18, we will provide opportunities for residents to participate in meetings, such as online, telephone or written submissions. The agenda for the January 18 meeting will be posted to the City's website on January 14 at which time we will advise how members of the public can best participate. Ensuring meetings are accessible to the public continues to be an important principle we are working to provide in these challenging times.

Council meetings are webstreamed from the City's website and may be viewed live or archived for viewing at another time. Minutes and meeting highlights may be viewed on our website with notice provided on our social media channels. Council encourages residents to reach out via email or phone and to stay informed through virtual means until we can safely resume in-person activities. ### 2021 Licence Renewals

Business licence and dog licence renewals will be mailed to residents and businesses on January 4 and will be due January 31, 2021. Should there be no additional provincial COVID-19 orders, dog licences can be paid in-person at City Hall after January 4 (no payments in December). Due by January 31, business licences may be paid by mail, drop box at City Hall, in-person or by credit card (VISA or Mastercard). Details will be included with the renewal invoices.
