

Parksville Outdoor Theatre Information Sheet

Parksville Beach Festival Society is operating and managing the outdoor theatre on behalf of the City of Parksville. Our goal is to offer the facility to the community at reasonable rental rates while also raising sufficient funds to cover the operational costs of the facility, the responsibility of Beach Festival Society. (Note: Rental rate includes a facility manager onsite during the entire rental period. Setup and teardown time will be counted as rental hours).

Rental of in-house sound and lighting systems - \$600

Renters are welcome to bring in their own sound or lighting; however, we also offer the option of renting our state-of-the-art system which includes a professional technician, an assistant, and the following equipment.

Allen and Heath 24 channel digital mixer, Allen & Heath 24 input stagebox, 4 - Yamaha 12" bi-amped two-way speakers w/rotatable horn, 2 - Yamaha 18" subwoofers, 4 - 12" coaxial powered wedge monitors (1000w) 2-15" JBL monitors, all vocal and instrument microphones, stands, and all associated cabling.

Conditions of rental

Theatre events that attract an audience and will require use of the Performance Venue Area must obtain a City of Parkville Theatre Event Permit. The Beach Festival Society will assist renters in the completion of the event permit. A \$500 damage deposit payable to the City of Parkville must accompany the event permit application. Following the event, the deposit will be returned if no damage occurred.

All renters must carry a minimum of \$2 million liability insurance. The applicant must obtain and provide a copy of valid comprehensive general liability insurance protecting the City of Parkville and the Parkville Beach Festival Society against liability for bodily injury, death, or property damage, arising out of the event.

Minimum limit of \$2 million commercial general liability insurance against third-party claims for bodily injury, death, property, and loss of use. Note: a higher limit of liability insurance might be required depending on event-specific details (such as traffic impacts, attendance numbers, length of event). **Events which include the serving of alcohol must carry a minimum \$5 million in general liability insurance and must also apply to the City of Parkville for a beer garden permit.** Maximum deductible of \$5,000 per occurrence, with cross liability clause.

Ticketed events

The beautiful park setting combined with a world class facility, top quality sound equipment and technicians, an area that can hold several thousand people and an available box office to sell tickets make this an outstanding venue to host ticketed events. The Beach Festival Society has recently purchased 6-foot-high fencing complete with privacy screening that can be installed around the perimeter of the concert venue. The fence cost, including installation and removal, is \$1 per ticket sold with a minimum charge of \$600.

Ticketed events will be required to pay the following charge to the City of Parkville:

Not for profit ticketed event	\$1 per ticket
For profit ticketed event	\$2 per ticket
